**I.A.9361/2017**

Keeping in view the averments in the application, plaintiff is exempted from filing the certified/clearer/proper/translated copies of documents at this stage.

Needless to say, this order is without prejudice to the rights and contentions of the parties.

Accordingly, present application stands disposed of.

**I.A.9362/2017 (Section 80)**

Issue notice to defendants No.73 and 74 by all modes including dasti, returnable for 23<sup>rd</sup> October, 2017 before the Joint Registrar.

**I.A.9363/2017**

Present application has been filed seeking enlargement of time in filing the court fees.

Learned counsel for the plaintiff prays for and is permitted to file the deficient court fees within ten days.

Accordingly, the application stands disposed of.

**CS(COMM) 541/2017**

Let the plaint be registered as suit.

Issue summons in the suit to the defendants by all modes including dasti, returnable for 23<sup>rd</sup> October, 2017 before the Court.

The summons to the defendants shall indicate that a written statement to the plaint shall be positively filed within four weeks of the receipt of the summons. Liberty is given to the plaintiffs to file a replication within two weeks of the receipt of the advance copy of the written statement.

The parties shall file all original documents in support of their respective claims along with their respective pleadings. In case parties are placing reliance on a document which is not in their power and possession, its detail and source shall be mentioned in the list of reliance which shall be also filed with the pleadings.

Admission/denial of documents shall be filed on affidavit by the parties within two weeks of the completion of the pleadings. The affidavit shall include the list of the documents of the other party. The deponent shall indicate its position with regard to the documents against the particulars of each document.

**I.A.9360/2017 (U/o 39 Rules 1 & 2)**

Issue notice to defendants by all modes including dasti, returnable for 23<sup>rd</sup> October, 2017 before the Court.

It is pertinent to mention that present suit has been filed for permanent injunction restraining infringement of copyright, accounts of profits, delivery up, damages etc.

It is stated in the plaint that the plaintiff is a leading production and distribution company in India and the exclusive licensee of Media Rights with respect to various films across varied genres and languages. The plaintiff is the author/producer of the film "A GENTLEMAN-SUNDAR, SUSHIL, RISKY" slated to be released theatrically in India on 25<sup>th</sup> August, 2017 under Section 2(d) of the Copyright Act and is the owner of the Copyright in the film as per Section 17 of the Copyright Act and also has exclusive rights as enumerated under Section 14(d) of the Copyright Act.

It is also stated in the plaint that defendants No. 1 to 50 are a network of rogue websites which are primarily indulging in the business of hosting, streaming, making available for viewing and download and communicating to the public third party content and information through medium of internet and mobile transmission. The content which is offered by defendants No.1 to 50 is pre-dominantly pirated and illegal, infringing the rights of legitimate intellectual property right owners.

Learned counsel for the plaintiff states that the plaintiff employed the services of an investigating agency Markscan and found out that the defendants No.1 to 50 are providing illegal content for viewing and download through defendants No.51 to 72/Internet Service Providers thereby infringing plaintiff's exclusive rights and causing losses to them.

He further states that the plaintiff apprehends that the exclusive rights of the plaintiff's film "A GENTLEMAN-SUNDAR, SUSHIL, RISKY" is also likely to be infringed by illegal activities of these rogue websites.

It is stated that this is not the first case of this nature that has been instituted in the Court. In the recent past, several similar suits like CS(OS) No.384/2011, CS(OS) No.821/2011, CS(OS) No.1724/2011, CS(OS) No.2066/2011, CS(OS) No.2352/2011 and CS(COMM) 376/2017 have been filed by various entities against rogue websites and directions have been issued by the Court to the internet service providers to disable access to the rogue websites.

Keeping in view the aforesaid, this Court is of the opinion that a *prima facie* case is made out in favour of the plaintiff and balance of convenience is also in its favour. Further, irreparable harm or injury would be caused to the plaintiff if an interim injunction order is not passed.

Consequently, till further orders, the defendants No. 1 to 50, their owners, partners, proprietors, officers, servants, employees and all others in capacity of principal or agent acting for and/or on their behalf are restrained from communicating, hosting, streaming, making available for viewing and downloading without authorisation, on their websites or other platforms through the internet the film "A GENTLEMAN-SUNDAR, SUSHIL, RISKY" in any manner whatsoever. Defendants No.51 to 72 shall ensure compliance of this order by blocking the websites of the defendants No.1 to 50 and the access to the rogue websites identified in the memo of parties.

Defendants No.73 and 74 are directed to issue requisite Notifications directing defendants No.51 to 72 and other internet and telecom service providers registered under them to block the websites of defendants No.1 to

50 and those that have been identified in the memo of parties.

Defendant nos. 51 to 72 and defendant nos. 73 and 74 are also directed to, on receipt of communication from the plaintiffs of any other website hosting the said movie, block such website also.

Let provisions of Order 39 Rule 3 CPC be complied within a period of one week.
