# P.C.:

1. I am prima facie satisfied that Respondent Nos. 2 to 4 in above Petition, have cheated not only the Petitioner but also Guy in the Sky Pictures Private Limited, J.A. Entertainment Private Limited, Pooja Entertainment and Films Limited, Pooja Film Company, Padma Ispat Private Limited, SPE Films Private Limited and others. The Respondent No. 1 Company of whose Respondent Nos. 2 to 4 are the Directors, have also prevented the Court from passing any orders by representing to the Defendants in the above Suits and this Court that they are willing to settle the matter and in fact purportedly settled the said matter by signing the Consent Minutes of Order dated

20<sup>th</sup> April, 2018 and thereafter committed breach of the undertakings given to the Court more particularly in paragraphs 8 (a) and 8 (b) of the Consent Terms. In short, not a single term, which was agreed upon under the said Consent Terms, have been complied with by Respondent No. 1.

- 2. The Deputy Commissioner of Police under whose jurisdiction Khar Police Station, Mumbai is situated shall appear before this Court on the adjourned date and inform the Court what steps are taken in response to the Complaint dated 26<sup>th</sup> April, 2018 filed by Guy in the Sky Pictures Private Limited.
- 3. Respondent Nos. 1 to 4 to file their Affidavit disclosing all assets (movable / immovable) of Respondent No. 1 as well as their personal assets including the rights created in respect of various films in favour of various parties.
- 4. Respondent No. 5 is permitted to deposit an amount of Rs.81 Lacs to the Government of India towards income tax on behalf of Respondent No. 1.
- 5. Stand over to 7<sup>th</sup> May, 2018 at 03.00 p.m. when Respondent Nos. 2 to 4 shall remain present before this Court.
