I.A. 16143/2025 (u/O XI Rule 1 (4) of CPC, 1908)

1. The present application has been filed on behalf of the plaintiff seeking leave to file additional documents under the Commercial Courts Act, 2015.

2. The plaintiff is permitted to file additional documents in accordance with the provisions of the Commercial Courts Act, 2015 and the Delhi High Court (Original Side) Rules, 2018.

3. Accordingly, the application is disposed of.

I.A. 16144/2025 (u/S 12-A of Commercial Courts Act, 2015)

4. As the present suit contemplates urgent interim relief, in light of the judgment of the Supreme Court in *Yamini Manohar v. T.K.D. Krithi*, 2023



SCC Online SC 1382, exemption from the requirement of pre-institution mediation is granted.

5. The application stands disposed of.

I.A. 16145/2025 (u/S 80 of CPC, 1908)

6. The present application has been filed on behalf of the plaintiff under Section 151 of the Code of Civil Procedure, 1908 seeking exemption from two months' prior notice upon the defendants no.82, 85, 90 and 91.

7. In view of the urgent relief sought, exemption is granted to the plaintiff from serving the requisite notice to the defendants no.82, 85, 90 and 91, under Section 80 of the Code of Civil Procedure, 1908 ('CPC').

8. The application stands disposed of.

I.A. 16142/2025 (u/O XXXIX Rules 1 and 2 of CPC, 1908)

9. The present suit has been filed seeking relief of permanent injunction, restraining infringement of copyright along with other ancillary reliefs.

10. The plaintiff claims copyright in the following works (hereinafter, "the plaintiff's works"), details of which are given in the table below:

11. The plaintiff is a listed company and a key player in the Indian market



and media industry, primarily engaged in the production, distribution, and exploitation of feature films, web series and other audio-visual content.

12. Defendants no.1 to 56 are websites, which are engaged in unauthorized streaming of the pirated and unlicensed content including movies owned by third parties. The defendants no.57 to 80 are the Domain Name Registrars (DNRs) in respect of the defendants no.1 to 56. The plaintiff apprehends that said defendants no.1 to 56 will stream the plaintiff's exclusive cinematographic work.

13. In light of the above, it is contended that the defendants no. 1 to 56 are liable for infringement of the plaintiff's copyright works under Section 51(a)(ii), Section 51(b) and Section 51(a)(i) of the Act, for making a copy of the original content, including storing of it in any medium by electronic or other means and communicating the original content to the public, the hosting, streaming, reproducing, distributing, making available to the public, and/or communicating to the public of the original content for streaming and downloading, or facilitating the same, without authorization of the plaintiff. In support of the aforesaid contention, reliance is placed on the decision of this court in CS(COMM) 724 of 2017 dated 10th April, 2019 titled ***UTV Software Communication Ltd. &Anr. v. 1337x.to and Ors.***

14. It is further contended by the plaintiff's counsel that majority of the defendants no. 1-56's websites are anonymous in nature and the information provided in the public domain regarding the owners of the website is either incomplete, incorrect and/or protected behind a veil of secrecy. These websites hide behind domain privacy services offered by various Domain Name Registrars, which enable a website owner to hide behind a veil and not disclose any contact details publicly, to protect his privacy.



15. In order to overcome this, the plaintiff has arrayed various internet and telecom services providers (ISPs) as the defendants no. 81 to 89 (hereinafter "the said ISPs"), Department of Telecommunication (DoT) as the defendant no. 90, Ministry of Electronics and Information Technology (MEITY) as the defendant no. 91 in the present suit to ensure the effective implementation of orders passed by this Court.

16. Issue notice

17. Notice is accepted by counsel appearing for the defendants no. 90 and 91.

18. Notice be issued to the defendants no. 1 to 56 through e-mail alone and to the defendants no. 57 to 89 *via* all permissible modes.

19. Reply (ies) be filed within four (4) weeks.

20. Rejoinder(s) thereto, if any, be filed within two (2) weeks thereafter.

21. In view of the averments noted hereinabove and in view of the judgment passed in ***UTV Software Communication Ltd.*** (*supra*), this Court is of the opinion that a *prima facie* case is made out in favour of the plaintiff. Balance of convenience is also in favour of the plaintiff and against the defendants. Further, irreparable harm or injury would be caused to the plaintiff if an interim injunction order is not passed.

22. Accordingly, till the next date of hearing, the following directions are issued:

- a. The defendants no. 1 to 56 (***Annexure-A*** of the present order), their owners, partners, proprietors, officers, servants, employees, and all others in capacity of principal or agent acting for and on their behalf, or anyone claiming through, by or under them, are restrained from communicating, hosting, streaming, and / or making available for



viewing and downloading in any manner, without authorization, on their websites or other platforms, through the internet in any manner whatsoever, the plaintiff's works and content related thereto.

- b. The defendants no. 57 to 80 (DNRs) and their directors, partners, proprietors, officers, affiliates, servants, employees, and all others in capacity of principal or agent acting for and, on their behalf, or anyone claiming through, by or through them, are directed to lock and suspend the domain name registration of the defendants no. 1 to 56, as per the details given in **Annexure- B** of the present order.
- c. The defendants no. 57 to 80 (DNRs) are directed to disclose the following information:
 - i. Complete details (such as Name, Address, Email address, Phone Number, IP Address etc.) of the defendants no. 1 to 56;
 - ii. Mode of payment along with payment details used for registration of domain name by the Registrant i.e., defendants no. 1 to 56.
- d. The defendants no. 81 to 89, their directors, partners, proprietors, officers, affiliates, servants, employees, and all others in capacity of principal or agent acting for and on their behalf, or anyone claiming through, by or under it, are directed to block access to the various websites (defendants no. 1 to 56) identified by the plaintiff, details of which are given as **Annexure- A**.
- e. The defendants no. 90 and 91 are directed to issue a notification calling upon the various internet and telecom service providers



registered under them to block access to the defendants no. 1 to 56 (rogue websites), details of which are given as *Annexure- A*.

- f. If during the pendency of the present suit, any further websites are discovered by the plaintiff, which are illegally streaming the infringing content as identified in the present suit, copyright of which is owned by the plaintiff, the plaintiff is granted liberty to communicate the details of such websites to the defendant no. 90 (Department of Telecommunications) and the defendant no. 91 (Ministry of Electronics and Information Technology), for issuance of blocking orders and simultaneously to the Internet Service Providers (“ISPs”) for blocking the said websites.
- g. The DOT and MEITY shall also issue necessary blocking orders immediately upon the plaintiff, communicating the details of the websites, which are illegally streaming the content, over which the plaintiff has rights.
- h. Upon receiving intimation from DOT/MEITY, the ISPs shall take steps to immediately block the rogue websites in question.
- i. After communication of details of the rogue websites to the concerned authorities, the plaintiff shall continue to file affidavits with the Court, in order to ensure that the Court is fully informed of the websites in respect of which blocking orders are sought.
- j. If any website, which is not primarily an infringing site, is blocked pursuant to the present order, they shall be permitted to approach this Court by giving an undertaking that it does not intend to engage in any unauthorized streaming of any content, over which the plaintiff has rights.



- k. As and when new further websites are discovered by the plaintiff, the plaintiff shall be at liberty to file an application for their impleadment, which shall be taken up before the Joint Registrar, and the order passed today shall be extended to the said newly impleaded website(s) as well.
23. In view of the fact that there are several defendants involved, compliance with Order XXXIX Rule 3 of the CPC shall be filed within seven (7) days from today.
24. List before the Joint Registrar on 15th September, 2025 for completion of service and pleadings.
25. List before the Court on 17th November, 2025.
